Chapter I Admission

Article 1

This rule is based on the school rules and related regulations.

Article 2

Those who participate in the Ph.D. course entrance examination for admission to the Institute or have applied for a postgraduate doctoral degree in the postgraduate and postgraduate master's degree classes of the Institute are admitted to the Institute to study for a doctorate in law.

Article 3

The qualifications for taking a doctoral class, the subjects for the examination and the quota for admission to the entrance examination are approved by the office meeting, the admission committee of the school, and sent to the Ministry of Education for review.

Chapter II Study Courses

Article 4

In addition to the stipulations of the school regulations, the postgraduates of doctoral classes shall apply for a period of at least two years and a maximum of seven years.

Graduates who have been approved by the project for physical and mental reasons or for learning needs may have to extend their years of study for up to two more years.

Graduates who have been pregnant, produced or reared for children under the age of three, and who have obtained a certification document for approval by the project application may be required to extend the period of study for up to two years. When necessary, it may be necessary to apply for a special project to extend the period of study for up to two years.

Article 5

Ph.D. programs are divided into two areas of study: public law and private law. Graduate students of doctoral programs may choose their own fields of study.

Article 6

The minimum academic score for a doctoral class is 18 credits. It does not include 12 credits for graduation thesis, legal language, other research institutes of the school,

and credits selected by the external school system.

Before completing the graduation grade for this school, at least one course should be selected per semester, and the maximum limit for each semester course is 6 credits. Article 7

The ability of foreign language graduates for doctoral degree graduates to enter school or graduate should meet the standards set out in the attached table.

When a Ph.D. student graduates, he or she can take a course in eight foreign languages (English, Japanese, German, or French law, or a selective reading of a masterpiece).

Article 7-2

Foreign Ph.D. students studying in the curriculum are mutatis mutandis to doctoral students of this nationality. Those who choose to undertake doctoral programs in other institutes of this school must not exceed 6 credits.

Chapter III Dissertation Guidance

Article 8

The doctoral graduate student selecting the thesis can go to the office to take the professor guidance consent form and negotiate with the guidance professor to apply for the thesis topic, then the fill it out and get the approval of the guidance professor. The director will submit the report to the Office and report to the office meeting.

Article 9

The doctoral dissertation supervisor should have a doctorate and have one of the following qualifications:

First, he served as a professor, associate professor or assistant professor for more than three years and served as a teacher of the relevant discipline of the doctoral dissertation.

2. Academician of Academia Sinica has been a researcher, associate researcher or assistant researcher of Academia Sinica for more than three years, and he has a special researcher in the discipline of doctoral dissertation.

Article 10

Doctoral graduate students who are invited to apply for dissertation guidance shall be limited to full-time teachers of the Institute. However, there are special circumstances that require the approval of the meeting of the local government and the extension of a full-time teacher's guidance.

If the above item is to be a post of a full-time teacher instructor, the full-time teacher of the Institute shall be further deferred to the co-director's guidance.

Article 11

All matters relating to the dissertation by doctoral graduate students shall be guided by the guidance professor. Change of guidance professor should be approved by the original and new guidance professor, the sent to the office.

The retired or resigned teacher of this school may continue to instruct the student before his or her graduation, but if the retired or resigned teacher is unwilling to continue the guidance, or the student is unwilling to continue to be guided by him, he must submit the approval of the meeting of the office and release the guidance relationship. Not subject to the preceding paragraph.

Chapter IV Degree Examination

Article 12

Doctoral graduate students must pass the Qualification Examination, before they can apply for the Doctoral Degree Examination.

Article 13

Doctoral graduate students who complete the doctoral degree qualification courses and pass qualifications can obtain doctoral candidate qualifications.

Article 14

A doctoral candidate may apply for a doctoral degree examination after completing the thesis and publishing at least two anonymously reviewed journal articles, monographs, or seminar papers during the period of study.

If the doctoral students are co-authors of the above-mentioned journal articles, monographs or seminar papers, they should be credited in proportion to their contributions within these works. Doctoral students' publications co-authored with their supervisors before calendar year 2014 should be counted as their own publications.

The content of the work proposed by the Ph.D. candidate should be related to his or her thesis.

Article 15

An application for a degree examination shall be submitted at the time specified in the school calendar, and the candidate should get the paper examination application form two copies, the degree examination member list from the office. The PhD Exam Committee consists of 5 to 9 professors and associate professors in and out of the university. All the members are selected by the guidance professors, submitted to the Institute for PhD examination and the Examination Committee Qualification Review Committee for approval, and reported to the principal for appointment.

Article 16

The doctoral degree examination shall be conducted by oral examination.

Ph.D. examinations should be held within the deadline set by the school calendar. If it cannot be held for some reason, it shall be held no later than the end of the semester. Otherwise, the application for the revoked degree examination should be submitted before the end of the semester. If it has not been revoked, the same examination will be regarded as failing.

Article 17

When applying for a degree examination, postgraduate doctoral students should pay 6 papers (instruction professors, papers examination committees, and a copy of their offices) for the postgraduates of doctoral programs. The format of the papers should be handled according to the format of the master's thesis.

Article 17

The foreign doctoral candidates can present his outlines, doctoral qualifications, thesis writing, and degree examinations in English.

Chapter V Procedures for leaving school

Article 18

After passing the postgraduate degree examination and revising it according to the requirements of the paper examination committee member, it shall be sent to the convener of the degree examination committee for examination and approval. After reviewing and confirming by the convener of the degree examination committee, several paperback papers are sent for exchange with other universities and an electronic paper (including abstract and full text) to the office. One paperback papers to the registration office of the Academic Affairs Office; two paperback papers to the Library and Information Service. The format of the paper is handled according to the format of the Master's thesis.

Article 19

The doctoral student can apply for leaving school procedures after registering the abstracts (500 words to 1000 words), key words, items, and references of the papers

at Ocean University's Master's thesis online filing system and getting the director and the assistant professor checked and submitting the National Library of China's Master's thesis electronic file online authorization to your office

Chapter VI Supplementary Provisions

Article 21

These regulations could be changed because of the establishment and change of the regulations of the school's Master's Program or the doctor's and master's degree exams, and the need for academic development of this school after the resolution of the office meeting.

Article 22

The amendments (increased) to these regulations are not retroactive if there are restrictions and requirements beyond the existing ones. However, the revised content is beneficial to students, not limited to this.

Article 23

This rule shall be issued after the adoption of the Academic Affairs Conference.

Remarks:

1. The standards for admission and graduation as listed above are limited to those obtained within three years of enrollment or graduation.

2. Other admission criteria:

(1) Those who hold a bachelor's, master's degree, or master's student still studying in a foreign university or an independent college recognized by the Ministry of Education can take the foreign university degree certificate or master's degree study certificate as the proof of the language ability when registering.

(2) Those who hold the English proficiency test for English teachers of national elementary schools of the Ministry of Education can take the copy of the transcript as the proof of the language ability.

(3) Holders of the German University Admission for Foreign Languages Proficiency Test (DSH) are eligible to pass the test certificate for proof of alternative language ability.
